When is it too late?

Not too long ago I engaged in a brief discussion about why today's youth are being so hateful towards each other. This is a serious subject; we have children losing their lives over what other children see as harmless actions.

At least two high profile court cases have been introduced in recent days regarding this very topic. Major publications are reporting these tragic events. High profile celebrities and elected officials are calling for action. So my question is this: "Parents, are you seeing this?"



Parents, teachers and families are the front line observers in the battle. Yes, a battle for the safety of our children. With the rise of this issue, with the tragedy we see more often than not and the increased reports of horrible actions taken by children against children, I am beginning to wonder who in the world is watching?

We all have seen, or remember, the kid who always gets his or her way at home and believes that with that emboldened spirit they can be held harmless at school. One action leads to another and the rest is history. My friends: as parents, teachers and families we need to take action before this battle becomes an uncontrollable war.

Parents: please engage your children and let them know how wrong bullying can be. Support schools that work towards bullying prevention and help create programs for bullying prevention where they do not exist. Teachers: help parents understand what they can do to help you identify this issue. Help parents understand what you see every day. Families: do not be afraid to seek assistance from the school, medical officials or law enforcement if needed.

These are bold comments but we are fastly getting to a point that if we do not address this problem it may just be our child, or a neighbor's child, on the front page next.

What is a Regional Director?

A Regional Director is the liaison from Missouri PTA to your unit and is under the direction of the VP of Field Service. Your Regional Director is in contact with Unit and Council Presidents and serves as a resource. A Regional Director may attend your meetings, if you would like. They are available to help with training, through Schools of Information or Regional Conferences. They will also be in contact to help you become and remain a "Unit in Good Standing."

Missouri PTA is divided into 8 regions. Foothills; Gateway; Heritage; Mark Twain; Meramec; Ozark; Pony Express; and Three Trails:

- Gateway has 2 Regional Directors: Pat Higginbotham and Renee Benjamin.
- Meramec has 1 Regional Director: Joyce Asher
- Heritage has 1 acting Regional Director: Kim Weber.
- Ozark has 3 Regional Directors: Elizabeth Aley, Tracy Sayre and Jessica Bruner.
- Pony Express has 1Regional Director: Linda Wansing.

 Three Trails has 2 Regional Directors: Joanne Schwartz and Lou Hibdon

We have no Regional Directors in the Foot Hills or Mark Twain regions. If you are interested, or even think you might be interested, please fill out a talent bank form (available on mopta. org) and send it to the state office.

Your Regional Director will be in contact with you this summer. Their contact information is on page 13 of this issue of *CONTACT*. You may contact me (patb@mopta.org) with any questions you have regarding Regional Directors.



Unit in Good Standing

Local PTA units must be deemed to be "in good standing" in order to fully participate in the programs and benefits offered by the association. A PTA unit is "in good standing" if it:

- Adheres to the Purposes and basic policies of the PTA;
- Remits national and state dues to the state PTA by dates required;
- Has bylaws approved every three years according to the procedures of the state PTA;
- Submits a copy of the unit's annual financial report to the state PTA by December 1st of each year;
- Submits a copy of the unit's annual financial review (formerly known as the audit) to the state PTA by December 1st of each year;
- Submits a copy of the required IRS tax form to the state PTA by December 1st of each year;
- Submits the names and addresses of officers to the state PTA by March 31st of each year; and
- Meets other criteria as may be prescribed by the state PTA.

If a local PTA becomes "not in good standing," as soon as it has fulfilled the necessary requirements, it is again considered "in good standing".

If your unit is affiliated with a council, please check for additional requirements that may be prescribed by the council PTA in order to fully participate in programs and services offered by the council.

By virtue of being part of National and the state PTA, the IRS grants a local unit PTA non-profit (501(c)(3)) status. This requires PTAs to be non-partisan, non-sectarian, and non-commercial. PTAs cannot endorse political candidates or parties. PTAs are not religious nor do they endorse products, services, or companies.

If a PTA is <u>not</u> in good standing, neither the unit nor the students attending the PTA's school are eligible to receive awards (this includes but is not limited to <u>membership awards</u> and the state's Reflections contest).

Communications Made Easy – Creating Peer Groups

One of the unique aspects of Just Between Friends is the ability to create a peer group for effective communications. This feature of Just Between Friends is so effective in creating groups and communicating with group members, National PTA has adopted it this year to communicate with State PTAs.

Log onto the system and select the people you'd like to have in the group. Send them an invitation to join and include a codeword that you create. Just Between Friends refers to this codeword as a token on the system. When invited people join the group, you'll be able to communicate to keep them updated about the group's activities. The system also sends automatic reminders for events and deadlines.

We encourage to check out the Just Between Friends communication system. It's offered free to local PTAs to strengthen your PTA and simplify the lives of leaders and members.

O+ Ways to Start Your Membership Campaign Off Right!

- START NOW! It is never too early to start planning. A well planned membership campaign is ready to go by the first day of school or before.
- HAVE THE MEMBERSHIP COMMITTEE IN PLACE: Membership recruitment is a big job. Split the task into different areas so committee members can use their talents and no one person is overwhelmed.
- 3. SET A MEMBERSHIP GOAL: All good plans have a goal and a "map" on how to get there. 2-5% growth is obtainable for most units. Make sure everyone knows that goal and how you plan to reach it.
- BUDGET: Make sure your budget includes money for the promotion of your membership campaign.
- 1ST MEMBERS: Each of your unit's officers and chairmen need to be a member. Sign them up first!
- SCHOOL DISTRICT PARTNERS: Enlist the support of your superintendent and principal. Make sure each of your school board members are card carrying PTA members. Get permission to attend back-to-school meetings to promote your campaign and sign up staff as members.
- 6. BUSINESS PARTNERS: Attend Chamber of Commerce meetings to invite local businesses to join. Ask them to display posters for joining PTA. Give them the opportunity to support the work your PTA does and create ways to give visible recognition for that support.
- NEW FAMILIES: Provide realtors with PTA "Welcome" packets to give to all home buyers. Any person should be considered a potential member, not just parents of school age children.
- CREATE MEMBERSHIP INCENTIVES: Arrange for discounts or coupons for PTA members at local businesses or create awards for students and/or

- classrooms that reach 100% membership. Give away a token with each membership, such as a sticker, button, or pencil inscribed with your PTA's name.
- 9. NATIONAL BENEFIT PROVIDERS: Be sure to promote these along with any local incentives you may be offering. Provide details on how to access the benefits only to your PTA members not to the school as a whole.
- 10. BACK TO SCHOOL PTA PACKETS: Put together packets that inform, promote & invite. Tell prospective members 3 things your unit accomplished last year, 3 goals this year, 3 reasons why their membership is important to the children of your district, the children of Missouri and the children of our nation. This can also be their opportunity to sign up to volunteer for specific events or be a room parent.
- 11. BE VISIBLE: Make all events PTA membership events. Have a bulletin board showing the progress of your drive and an invitation to all to join.
- 12. FIRST DAY OF SCHOOL: Have a "welcome committee" present with a smile to help direct students & parents to classrooms. Hold a "First Day coffee gettogether" off campus - for new parents and those of us who still try to deal with first day trauma – it's a great opportunity to promote PTA.
- 13. MAIL DUES MONTHLY: Work closely with your treasurer to make sure the state and national dues are sent in on the first of each month. No one is officially a PTA member until their dues reach the state office.
- 14. TAKE A DEEP BREATH! You are doing great! Remember to use your resources, i.e. PTA Membership Quick Reference Guide, MO PTA website, or National PTA website if you have questions.
- 15. TOOT YOUR OWN HORN! Units/volunteers work hard for our children and deserve to be recognized. Take time to display the awards your unit has earned over the years. Look at this year's recognition to see how you are going to fit into the PTA Picture!

And the Winner Is......

Students Make A Difference Award Platte City Middle School PTSA, Pony Express Region

Application Award for the Unit with the highest percentage of student members based on school enrollment. This is the 2nd consecutive year Platte City Middle School PTSA has won this award.

Missouri PTA is very proud of all students who entered entries into this year's program, and we hope to see even more entries next year when the Reflections program theme is "Together We Can".






Missouri's National Reflections Winners

French Fries a Vegetable?

It's not very often anymore that one particular show on television can succeed in captivating my entire families' attention. However, when my husband stumbled upon *Jamie Oliver's Food Revolution* he was incredibly taken back by what he saw and heard. After relaying this astonishing first episode to me and our two children, one in middle and one in high school, the show was immediately programmed to record all episodes on the DVR.

While each of the episodes proved effective in causing us to scratch our heads and really think about the food we eat and how we view food, one episode in particular drummed up the most conversation. Incidentally my in-laws were in town visiting and happened to be seated in the living room when this episode aired. Previously they had seen previews for the show and watched interviews with Jamie Oliver on the morning shows. But this was the first episode they'd actually viewed. During one segment Jamie is struggling with the food administrator's decision that the healthy vegetable stir-fry meal he has created for the high school students does not contain enough vegetables to be considered a reimbursable meal. However, the meal offered in the line next to Jamie's, hamburgers and French fries did meet the requirements. When he questioned why, since the students were basically served in his view a protein, a starch and a starch, the response was - potatoes are considered a vegetable.

Immediately I looked over at my son and asked, "Do they serve French fries everyday in school"? Without a moment's hesitation he answered "yes" and then proceeded to add that they are offered hamburgers, fries and pizza every day. Honestly, I thought my mother-in-law was going to fall off the couch. It has been a long time since she had children in school and much has changed in the last 20 years since her youngest graduated. Thus began a fairly lengthy conversation between the six of us regarding what my children ate and drank each day at school, what their

friends consumed, and what they thought of the food in general. If one is what one eats, then is offering fries every day really such a good idea?

School cafeterias are filled to the brim with processed food. Why? Because it's cheap. Feeding thousands of students each day is time consuming and expensive. But, let's not just focus on school cafeterias. Drive down the street in any town and I'll bet the road is lined with fast food restaurants and convenience stores. Our fast natured lifestyles have given way to the rise of processed foods. Once again, they are not only cheap but also convenient. Shoot, you can even fill up your car at QuikTrip and then grab breakfast or lunch inside while you pay. Two birds – one stone right?

During the 2009 National PTA convention, I attended a workshop on Farm to School. The premise was to encourage schools and teachers to begin to incorporate fresh locally grown food in their cafeterias and classrooms. There were several interesting facts I learned during this workshop. Probably the biggest impact, for me, was the story told by a teacher who traveled around to elementary schools and conducted workshops on fresh vegetables. For years, when she was teaching, her classes actually grew and cultivated their own fruits and vegetables in a school garden. Workshop after workshop, in school after school, she was astonished by the number of children who had no inkling where their food came from or how it tasted raw. Most particularly, she was blown away while visiting a rural school where many of the children had never tasted a raw tomato. On her way to the school she had passed several tomato farms. While these farms were local, basically in the community, the children's interaction with tomatoes had always been after processing.

Bottom line, processed and 'fast' foods are not necessarily good for our bodies. Study after study has linked these food choices to many health problems such as heart disease, high blood pressure and obesity. There is a saying, If you look at

the list of ingredients on the back of food packaging and you see words your grandmother wouldn't recognize, don't eat it. Throughout the episodes of Jamie Oliver's Food Revolution, Jamie focused on changing one town, one community. He tried to open their eyes and bring awareness to how important good healthy food is for their health and well-being. After watching the entire series I personally felt the show achieved a bigger goal, at least where my family was concerned. Each one of us came away from that show empowered. Empowered to make better food choices and expect more from our food. No, I haven't marched up to the school and demanded they cease French fry production, but I did get my previously super picky son to try radishes. Believe me, that was a HUGE milestone.

Promoting Family Involvement — It's as easy as 1.2.3!

Unit and council members are now meeting to discuss next year's plans. Your strategies should include the incorporation of family involvement activities throughout the year. Research indicates that family involvement promotes student success. Students with involved parents are more likely to earn higher grades, go on to post-secondary education, and have better social skills. In addition, when families, schools and communities work together, student achievement, teacher and staff morale, and communication between these groups improves. As an added bonus, partnerships, as well as friendships, begin to develop. This creates a vibrant and supportive learning environment in which students thrive.

PTA units and councils can assist in building these partnerships with the National Standards for Family-School Partnerships. These Standards consist of three key steps:

- 1. Raising awareness about the power of family and community involvement
- 2. Taking action to grow family-school-community partnerships through specific programming and practices
- 3. Celebrating success as your school experiences increased involvement.

The National Standards for Family-School Partnerships Implementation Guide is a valuable tool for empowering people to work together and ultimately, building an environment for student success. Anyone with a stake in improving schools and student achievement can use this tool: PTA leaders, parents, school administrators, school board members, and community organizations. This Guide can assist organizers with implementing programs and policies which encourage family-school partnerships. Used with the supporting resources, it can help organizers educate communities about the importance of family involvement and direct the development of effective partnerships.

There are six National Standards for Family-School Partnerships and the full Implementation Guide is available for download at pta.org. The materials are best used after the formation of an Action Team whose mission is to focus on family involvement promotion. Team membership can consist of parents, caregivers, grandparents and other family members, school staff, community leaders, and PTA officers/members.

Hint: Strategies to develop and recruit members to this team can be included in next year's PTA plans!

The following standards are provided to assist in guiding the Action Team in forming successful Family-School-Community partnerships:

- Standard One Welcoming All Families into the School Community
 Create a welcoming climate.
 When parents walk into the school building, do they feel welcome?
 Is it a respectful, inclusive community?
- 2. Standard Two Communicating Effectively
 - Create regular opportunities for an open, honest dialogue.
 - Are the principal and other school administrators accessible to any parent? Does the school and PTA unit/council make it easy for parents and families to build connections and communicate with each other?
- 3. Standard Three Supporting Student Success
 - Keep families informed.
 - How does the school inform parents of standardized testing results in order to strengthen student skills?
 - Does the school and PTA unit/council report on school progress to the community?
- Standard Four Speaking Up for Every Child

Be a strong advocate for children. Do parents know the role of school and district staff and do they know who to contact?

Are parents informed of the federal and state law mandate which states that schools must involve and inform parents? Do parents know that by federal

- law, children have a right to qualified teachers?
- Standard Five Sharing Power
 Be a full partner in making decisions on
 issues affecting children, both at school
 and within the community.
 - What governance structures exist to discuss and weigh issues of equity, such as how are children eligible for the gifted program?
 - How do school council and PTA units/ councils develop and support leadership among parents?
- 6. Standard Six Collaborating with Community

Develop partnerships connecting the school with businesses, service clubs, social service agencies, youth organizations, etc. In what ways has support from community partners been organized?

What are the plans to turn the school into a hub of community life?

The Implementation Guide is meant to serve as an effective tool in developing greater involvement. Begin by reviewing the Guide and then just take one step at a time. You will be amazed at how much you can achieve! Begin by discussing these standards with your principal, PTA members and/or community leaders. Soon there will be dialogue between the various groups and partnerships will form. The important point is to start building an effective foundation from which you can build a program which best serves your school community.

Start today. Download the Implementation Guide and familiarize yourself with the standards. Action begins with you. Our children's ability to reach their potential depends on our commitment to these activities. - 6) Cook out / Friday Night tailgate at the school or High school



Nixa Council and "The Eagles Nest"



Walking through Nixa school buildings and seeing children whose pants were a little short or wearing a coat that was a little snug, I couldn't help but think, "I have all those items my kids have outgrown." Often times many families give these items to "Least of These", a local food and clothing bank, but I thought it might be helpful to have a location directly located in a district building for families of students. When the idea was presented to the Nixa Council PTA Board in July 2009 I was so excited! The Nixa Council Executive Board voted unanimously to support this project. We spoke with district personnel seeking guidance and asking if they saw the same needs. Their one response was "Put it down on paper and let's see what you come up with."

Many hours were spent researching clothing closets: how were they run, who did they help, what donations did they accept, and where were they located. What followed in the months to come were many meetings, e-mails, countless hours on the computer and Internet, and many presentations to district staff. It was not long before the vision was shared and others in the community saw the need as well.

The Nixa School District generously donated time and resources to remodel a portion of the NJH concession stand to create "The Eagles Nest – Where

Eagles Care and Share." The Eagles Nest is open Wednesdays from 10-2. We closed in May for the summer and reopen August 11. We have clothing in sizes birth to adult. We carry new socks and underwear as well. A generous donation of brand new washer and dryer has allowed us to make sure all items are clean and ready to wear. Nixa

students and their siblings are eligible to receive clothing and shoes based on a referral from school personnel, typically a school counselor. All Eagles Nest volunteers sign a confidentiality form and the referral from the district contains no identifying information. A family does not even need to tell us their children's names! We also work with "Least of These" to share resources and information.

A dream, a vision, an idea has now come to fruition because many in our community saw a need. We all saw a need to help students in Nixa. We have come together to lend a hand, to make a change, to make a brighter day for all the students in Nixa. All of us in the Nixa community are well aware of the effects

that the economy has had on each of us, even the youngest. In joining our efforts with the community, Nixa Council PTA wants to support families and students. Nixa Council PTA wants families to see The Eagles Nest as a positive resource for help. We are honored to help families and see the possibilities multiplied for students. It is all about giving to others. The delight on a child's face when they are presented with new clothes is truly overwhelming.

Students will be more successful in the classroom and have more self confidence when they have clothing that they can feel positive about. Nixa Council is excited to see students flourish and thrive as they achieve in the classroom.

The goal of the coalition is to get vital safety and recall information to every school and every parent to protect every child.

The National School Safety Coalition has launched the Click, Check and Protect Campaign to help safeguard children and inform parents, educators and caregivers about potential dangers. DISASTER RELIEF - A QUICK NOTE REGARDING DISASTER RELIEF AND PTA UNITS.

If a PTA is collecting funds, it is best to ask the donor to make the check payable to the agency receiving the funds. The PTA can collect the checks and forward them to the agency. It is better if the PTA does not deposit the money into its regular bank account.

If the PTA does deposit checks into its regular bank account, it will have to declare these funds as income. The PTA should keep accurate records of the deposit and disbursement of those funds.

A PTA can vote, per its bylaws, to donate its own funds to a relief agency, provided that that agency is a 501(c) (3) nonprofit organization. Any substantial contribution from PTA funds should be to an agency that focuses on a school- or student-related relief effort.

PTAs involved in disaster assistance must also consider how they will keep information about the beneficiaries confidential. A PTA may wish to partner with the school district or another community agency to guard the privacy of the displaced citizens and to ensure that donations get where they are most needed.
