The IRS and You: Why does it even matter?

"Me!?" you say? "ME and the IRS?" Does the mere mention of IRS bring trembles of fear to you? Do you dread the thought of filing 990s and wonder why you need do this at all? Do you wonder why the IRS and PTA are even related, after all the IRS is the government and PTAs are not? It's all because the relationship between the IRS and PTA is based on recognition and support of not-for-profit organizations. Fear not, PTA has the details worked out and if you follow your bylaws and general PTA recommendations your IRS status will be assured and you will live to tell of the experience.

Every PTA is a non-profit organization. A local PTA is part of Missouri PTA and National PTA which are established non-profit organizations. During chartering a local PTA adopts bylaws that include specific purposes and many business practices in common with Missouri PTA and National PTA, many of which are required of non-profit organizations; these portions of the bylaws are delineated by a # sign. It is the assurance of these practices that allows Missouri PTA to incorporate a new PTA unit into the PTA group as a non-profit organization. In contrast, an independent group must apply directly to the IRS to establish these same parameters and await individual approval by the IRS, such applications are accompanied by hefty application fees. Once established every non-profit organization has to prove to the IRS every year that they are conducting business as they were organized to do. PTAs provide this proof by filing a 990 and by retaining their "unit in good standing" status with Missouri PTA.

In 2006 the IRS required all non-profits to report regardless of their income. Groups were given a three year grace period to comply and last year those organizations with no 990 filings for three years lost their non-profit standing. This means they suddenly had to collect and pay taxes, their donors could no longer consider their donations tax deductible, and they were faced with trying to recoup their status. While there are procedures for reinstatement it is not simple nor is it free. It's much easier to file on time. If there are any errors in your filing the IRS will let you know and you can work with that much more easily than you can start over.

The PTA Purposes are defined in Article II of the bylaws and center on children, parents and schools. Ironically there is no fundraising detailed in the PTA Purposes at all, but PTAs need some funds to accomplish the Purposes. Those PTA funds come under the scrutiny of the IRS as part of the obligation of any non-profit organization. The more funds that are brought in as gross receipts, the more interested the IRS is in the details of the organization because the potential for fraud and abuse of the non-profit privileges increases as the funds increase. Depending upon gross receipts the PTA will use the IRS informational form 990 or 990-EZ with Schedule A, or the 990-N e-postcard.

The saying goes, "Put your money where your mouth is." and the filing of a 990 is your proof of just that. Gross receipts are the total of all funds brought into the PTA account(s) and are the key to which 990 is to be filed. For annual gross receipts of more than \$50,000 during the 2010-2011 year the IRS form 990 or 990EZ along with Schedule A are used. They are much more specific than the 990-N, they require that the PTA detail how funds were acquired and how they were used to accomplish the non-profit purposes. They also require a recap of the last five years' worth of records.

If your PTA had gross receipts of \$50,000 or less for the 2010-2011 year then you can file the much simpler 990-N e-postcard online. The 990-N essentially takes your promise that all is in order, collects contact information, and then sends you an email that the requirement has been satisfied. The gross receipts limit of \$50,000 is new for the 2010-2011year; filings of the 990-N e-postcard for previous years are limited to gross receipts of \$25,000.

National PTA has a publication just for treasurers, *PTA Money Matters Quick-Reference Guide* and Missouri PTA includes several pages just for treasurers in the 2011 *Tool Kit;* both were sent to presidents over the summer. These publications have instructions for the 990-N e-postcard filing online and pointers for completing the 990-EZ and Schedule A. There are also several pages of recommendations for safe handling of funds and documentation of your funds that will help when it comes time to file your 990. A treasurer should be able to file a 990-N online with relative ease. An individual who can read and follow directions can complete a 990-EZ and Schedule A. If a tax professional is used be sure they are experienced with non-profit organizations and they realize that your local unit is a subordinate of Missouri PTA.

All IRS filings are due the 15th day of the 5th month following the close of the fiscal year. If your fiscal year runs July 1 through June 30 then your IRS filing is due November 15. Do <u>not</u> put it off to the last minute.

Because PTAs are established as IRS 501(3)c non-profit organizations by recommendation of Missouri PTA, every year Missouri PTA is responsible to tell the IRS which PTAs are following the non-profit requirements. Missouri PTA evaluates this "unit in good standing" status by requiring documentation from local PTAs including: membership dues payment, current officers on file, updated bylaws, and three financial documents on file by December 1 each year: a) annual financial review (audit), b) treasurer's fiscal year-end report and c) a copy of the 990/Schedule A or 990-N confirmation email.

You can do this. Gather your instructions and documents. Do your homework. Start early. And then revel in your accomplishment when you are finished. Good luck!! You <u>can</u> do this!

Reflection

"Diversity Means..." – is the theme for the 2011-2012 Reflections Program. You might be thinking – it's November and too late to get started this year? Or, I will do this next year. Well I am here to tell you that it's not too late to implement a successful Reflections Program in your school for this year. How you might ask? Follow the simple steps listed here and you will have a successful program in your school. For those of you who have already started your program you can use these same simple steps to make sure that your entries are submitted to Missouri PTA correctly and on time.

- 1. Get the word out post your deadline and the location to get a copy of the art category rules in your school announcements, newsletters and on the web. Ask your school's faculty and staff to encourage the students and help promote Reflections. Keep it simple, but get the word out to all of your students.
- 2. Line Up your judges Contact members of your community and other schools who have a background in an art area and ask them to help you judge the artwork. Remember to provide the judges with the art category rules and the judges score card that are provided in the Missouri PTA Reflections Tool Kit.
- 3. Encourage students to participate Work with teachers and school administrators to provide incentives for all students who participate. Think outside the box on things that would encourage participation in this wonderful program. You might have to think of ways to explain and define the definition of "Diversity" to students in younger grades. Work with the teachers, they will know their students best.
- **4. Have your entries judged locally -** Have your submitted entries judged by your local judges. The three entries in each category within each age division in your school that score highest will be the entries you forward to Missouri PTA for judging.
- **5.** Make sure your unit is a "Unit in Good Standing" Verify with your president and treasurer that your PTA unit has

- satisfied all "Unit in Good Standing" criteria as outlined in the Missouri PTA Tool Kit.
- **6. Keep Local Unit Records** You should make photocopies of all literature pieces, and digital copies of all musical composition, film video production and dance choreography entries. If possible take digital photos of all photography and visual arts entries sent to Missouri PTA. This will ensure that the photography and visual arts entries submitted to Missouri PTA get returned to you in the spring. This will also help in the event that the electronic media for some reason gets damaged.
- 7. Complete all necessary paperwork for state judging Be sure to follow the steps outlined in the Missouri PTA Reflections tool kit and submit a Form A, a Form B for each age division, and that the student entry form is completed correctly. Entries without all paperwork completed will be excluded from judging at the state level. Make sure you have completed all of the items on the Local Unit Submission Checklist as found in the Missouri PTA Reflections Tool Kit
- 8. Send all entries to Missouri PTA by the deadline Once you have all of the paperwork completed and verified that your entries have followed all of the rules, make sure that they arrive at the Missouri State PTA Office no later than 4:30 p.m. on Friday January 19, 2012. Entries that arrive after this date and time will not be considered for judging.
- 9. Recognize All students that participated- Some schools host a "showcase" or art fair prior to sending the entries to Missouri PTA inviting students, parents and community members to the event. Students who participate in the Reflections program are honored with a certificate of participation or some other token of appreciation for their hard work. Also recognize those students whose entries are being sent to state PTA for judging on their achievements. Thank your judges for their time and effort spent judging all of your entries.
- **10. Have Fun** If students see that you are having fun and excited about the things they could and can create for you then they will be excited about participating and putting the effort into the project.

Rule Changes for 2011-2012: Make sure that each student submits the required consent form and that they have titled their entry. Entries without a title will be disqualified.

Full details for all of these steps can be found in the Missouri PTA Reflections Tool Kit that was distributed to all unit presidents this summer. The Reflections Tool Kit can also be found on the Missouri PTA web site. If you have questions please be sure to contact your council Reflections chairperson, your Regional Director, or the Missouri PTA Office.

Each year Missouri PTA is honored to award an outstanding unit with the Parent Education & Involvement Award. This award is given to a PTA unit that plans a program or project that focuses on bringing parents together to participate in a school activity. Research shows that parents who are involved raise students that are more academically aware and more adjusted throughout their school life.

Missouri PTA would like to commend Clinton County R3 PTA on their excellent program – PTA Back-to-School Splash Party. It is more important than ever to involve families. This program offers the opportunity for making friends with parents that may not have met if not for their hard work and dedication to the students of Clinton County R3.

Springfield Council of PTA's "Save a Life Tour" allowed two area high schools the opportunity to use a simulator and hard hitting messages to get up close and personal with what it is like to be involved in driving while drunk. The risks of what can happen with just one drink really brought home to students the consequences of this dangerous action.

Fairmount PTA from Independence involved everyone in their community by hosting a Crime fighting night! Each person was given a Detective Crime Fighting Manual that they took to eight different stations. While at the different stations, students and adults learned some valuable lessons. 911, who lives around you, what to do in case of an emergency, and how to be a good neighbor were just some of the activities presented to those participating.

Belair Elementary PTA in Jefferson City initiative for living healthy lifestyles was also chosen. Their mindset was to

change the way that they provide snacks at events. Changing out unhealthy foods and snacks to encouraging healthy snacks be provided at parties, map testing, and breakfasts was part of this mindset. They also hosted an annual open house meal. This also carried over to the way they fundraise. They hosted a 5k run to raise money for the school instead of unhealthy fundraising.

Blue Ridge Elementary PTA from Columbia started the BRE running club. BRE stands for A before school running club for students. Everyone involved keeps track of the amount of miles they run for the year, and awards are given to students when they reach milestones. This running carries over into the classroom, by studying a map to see the distance a person has ran. Different math equations based on the running are also used as examples in the class. In order to involve the community a 5K was also started to help fund the BRE club.

Congratulations to all of this year's winners. What a great way to involve students and your community in getting healthy and staying safe!


Communication awards



Town Hall Meetings: A Great Connection Between Legislators and the Community

Many people think that making a difference in the area of local and state government is a complicated and daunting task. MOPTA provides our members with simple steps to begin to connect with our legislators and having our voices heard. One of the most efficient and powerful ways to do this is to host a Town Hall Meeting in your area.

MOPTA Town Hall Meetings are gatherings that can include local, state, and federal legislators and members of the school, PTA, local businesses and the community. MOPTA provides the invitations to the legislators, a moderator, a specific set of questions to be presented to the legislators, and other background resources. The local Town Hall Meeting Coordinators decide who, where and when the event will be held and make other arrangements. We have found that our legislators appreciate the opportunity to meet with constituents, and your PTA members and local citizens will see advocacy in action.

The questions presented at these meetings are ones that reflect the legislative focus of MOPTA for the current year. The legislators are given the questions well in advance so that they can be informed and prepared to speak on these topics. By formatting our meetings in this way, the legislators, as well as the community, are hearing MOPTA positions on issues that are affecting Missouri's children today.

Hosting a MOPTA Town Hall Meeting is one of the requirements for the local Unit/Council AtLaw Award each year, and attending one of these meetings is a requirement to receive the

individual AtLaw Award. By hosting this event, you are well on your way to receiving the Unit/Council AtLaw Award as well as enabling your members to qualify for the individual award.

On pages 96-98 of the MOPTA 2011-2012 Tool Kit there are specific directions and suggestions for planning a Town Hall Meeting. The MOPTA Board of Managers is ready to assist you in making the arrangements and getting your event off the ground. Please consider hosting a Town Hall Meeting in your area. Right now is the time to begin. Find a location and a date that won't conflict with other school activities, and then call the MOPTA office to get the event on the calendar. We are excited to help you host a MOPTA Town Hall Meeting. You can make a difference with MOPTA.



Missouri PTR Legislative Priorities

Every year the Legislative Department develops a list of Legislative Priorities. These priorities are derived from resolutions and position statements that have been approved by the membership. Resolutions recently passed at convention will be evaluated by the Legislative department and then added to the 2012 Legislative platform. A complete list of resolutions and position statements are available on our website. Did you know that Missouri PTA supports:

- Legislation that protects and calls for local control of schools.
- A constitutional amendment permitting passage of school bonds by majority vote and raising the ceiling of indebtedness to 20%.
- Legislation to increase funding for programs and services aimed at the prevention of child abuse, neglect and maltreatment.
- Opposition to tax credits or tax deductions for tuition paid by

- a parent or sponsors for nonpublic elementary and secondary school children.
- Enforcement of legislation requiring school districts to have policies that promote increased parent involvement in their children's education.
- Legislation that will maintain or generate local and state funding for public education.
- State funding for renovation and construction of essential school facilities.
- Legislation strengthening laws to limit and restrict projects that reduce funding to public education through tax increment financing (TIF), urban redevelopment corporations and enterprise zones.
- Legislation and other efforts to cause class size reduction in Missouri schools.
