- 4. Think about the best time to hold your events. Consider what may affect your attendance the time of year (daylight hours, weather), any holidays, availability of organizers/performers/guests, and other activities that may clash with the date, for example sports and community events.
- 5. Now is the time to make changes. Eliminate events/activities that have low family and volunteer participation or are time intensive with little benefit.
- 6. Review your unit's Bylaws and standing rules.
- 7. Plan your budget with your Budget Committee. Review last year's budget and make needed changes.

Planning ahead will only help create a more successful school year and PTA involvement. Remember the most important thing is that people enjoy themselves and feel part of the school community. Happy planning!!



July marks a 10-year anniversary for me. But, this anniversary isn't one I'll mark with celebration or look back on fondly. Ten years ago on July 1st a drunk driver crossed the center line and hit the vehicle, in which I was a passenger, head on. Thankfully, I have very spotty memories of the events that took place after looking up from chatting with a friend to see a truck directly in front of us. It's weird the things you do and don't remember.

However, one thing I remember very clearly – my nurse in the Trauma room at North Kansas City Hospital telling me my kids were there in the waiting room. I distinctly remember telling him to not let them come back to see me. I absolutely didn't want them to see me like that. In the end I recovered from my injuries. I had great doctors, physical therapists, and supportive family to help me. In fact, my regional director (I was actually Council President for Liberty Council PTA at the time) helped me get around convention that year – she even cut my food for me.

Unfortunately, there is nothing remotely unique about my story. Stories like mine happen every day. The majority of people have experienced the effects of distracted drivers first hand or at least know of someone who has.

Summer marks months of celebrations and vacations. It also marks the 100 deadliest days for teen drivers. But it's not just teens who are driving distracted on the roads. According to the Center for Disease Control and Prevention, 8 people are killed and 1,161 injured each day due to distracted drivers. Sure you could argue that the drunk driver who hit me was more distracted then someone on their cell phone. But then again were they really? Driving at speeds of 55mph, the amount of time an average text message takes your eyes off the road is equivalent to the length of a football field. My accident happened in seconds – the amount of time it took to merely cross the center line on the highway.

This summer as you venture out to enjoy BBQs, vacations, and celebratory gathering, please remember to take note of your actions when driving. Be a good example for your kids, talk with you teen drivers about how important it is to arrive safely, and be mindful of others who might be distracted and sharing the road with you and your family. I wish you all a safe and statistic free summer.

FACEBOOK TIPS



Did You Know?

A <u>study from the Pew</u> <u>Research Center</u> revealed that three-quarters of online parents use Facebook, as do 70% of non-parents.





Facebook is a great way to do social media

marketing for your PTA, especially parents. The platform allows you to promote your PTA, connect with people online and share what is important to your members.

Port a Disclosure Statement

Set up rules of etiquette for your PTA's Facebook page so that everyone knows the rules and can help make it a safe place for sharing information. Check out <u>National</u> <u>PTA's Social Media Policy</u> for a sample policy disclosure.

Facabook Page or Group Page

National PTA recommends every unit <u>create a</u> page because they are much easier to update and reinforces our brand.

Unlike pages, groups do not allow you to add applications for promotions or advertising. Groups are often created for personal discussion rather than representing your PTA's brand as a whole.

Don't have a Facebook for your PTA yet? Learn how to create a page and be sure to assign at least two admins for the platform.

Prometa Pesta

With Facebook's <u>new alcorithm</u>, engagement on your Facebook page may be low. If you have budget to spare, try <u>"boosting" your posts</u>, or create an ad campaign for special annual events or tools that you want to promote.

Schedule Your Posts Strategically

Too many posts will cause people to hide or unlike your Facebook page. Ideally you should not post more than twice a day. However, your Facebook's Insidets will show when your audience is most active during the time of the day. Use it to your advantage.

Be Fun and Informative

Need inspirational ideas for posts? Try these different types of posts for your Facebook:

- PTA ennouncements
- Behind-the-scenes
- Question of the day
- Inspirational quotes
- Infographics
- Holidays/current events
- Discounts/freebies
- Blog posts & news articles



When you are not having to focus on planning events, running membership drives, or running fundraisers, summer is a great opportunity to work on creating your PTA website. Wordpress is a great tool for website building. There are two verisons: <u>Wordpress.com</u> and <u>Wordpress.</u> <u>org</u>. Wordpress.com is a free option to create a website. It is a very userfriendly tool; it takes you step by step through picking your theme and setting everything up. After the initial setup, they have tutorials that allow you to learn how to manage your website and add to it. Wordpress.org is for serious website-builders. It is a paid version, and has more options for plug-ins and website upgrades. If you aren't sure if your website will be worth investing in, you can start with the free version at wordpress.com and then move it over to wordpress.org if it takes off. Happy building!

As we start our school year, we always encourage our children to start the year on the right foot to have a good school year. As a unit leader you need to make sure your unit starts their school year off on the right foot also – to do this you need to make sure your unit is a unit in good standing. What does it mean to be a unit in good standing?

- Adheres to the Purposes and basic polices of PTA;
- 2. 3. Remits national and state dues to the state PTA monthly;
- Your Bylaws have been reviewed in the last three years and are current. If you don't know what your bylaws review date is you can contact the office, the Vice President and Director of Field Service, or the State Procedures and Bylaws Chair to determine your bylaws date. If your bylaws are out of date, you can contact your regional director for assistance in amending and submitting updated bylaws. Missouri PTA must have received your unit's fiscal year-end
- 4. report by December 1st, 2015.
- 5. Missouri PTA must have received a copy of your annual financial review by December 1st, 2015.
- Missouri PTA must have received a copy of your IRS submission 6. by December 1st, 2015.
- 7 Missouri PTA must have received your officers for the 2016-2017 school year. Even if your officers are returning, you must submit

them to Missouri PTA. The easiest way is to use the incoming officers form.

8. Meets other criteria as may be prescribed by the state PTA.

These are the criteria as written in your bylaws, you as unit leaders are responsible for making sure your unit meets these criteria each and every year. If you have missed one of the deadlines your unit is not in good standing until you have submitted the required item(s). So for example, if you missed the deadline of March 31st, you can submit your officers to the Missouri PTA office now and once those have been received your unit will be back in good standing. Remember, to be in good standing your units must have turned in all required documentation.

Missouri PTA has implemented a system of online notification, that allows each of our units the ability to review your status at any given time. If you need your login ID to our website, which will allow you to see all of this information, you can contact the office, your regional director or the Vice President and Director of Field Service.

Just like you ask your students to do the best that they can in regards to their school work, so must we do our due diligence in making sure we put our best foot forward in running our PTA.

The Missouri Legislature has wrapped up this term. Missouri PTA has been following Bills pertinent to the children of Missouri. We were successful in the passage of several bills (and had our amendment added to a Bill we opposed) that are currently waiting Governor Nixon's signature. I would like to highlight those Bills that may be signed into law. I have included actions Missouri PTA took on each. Thank you to everyone who called and emailed our elected officials and please continue to do so in the coming year.

HB 1995, Cornejo (R-064), would amend the current law regarding 1st degree murder and youth under 18. Currently Missouri's law is in violation of the U.S. Supreme Court decision in Miller V. Alabama (2012) that ruled mandatory life without eligibility for parole for youth was unconstitutional for individuals under 18. The U.S. Supreme Court extended this ruling retroactively on January 25, 2016. HB 1995 eliminates life without parole for children, establishes sentencing terms between 25-40 years, requires judges and parole boards consideration of youth-related mitigating factors, and creates a procedure for those previously sentenced to petition for review. We do not support SB 590 and HB 2084. These bills sentence those who are 16 and older to a minimum of 50 years and those under 16 a minimum of 35 years. PTA sides with the longstanding Juvenile Justice philosophy that rehabilitation should take precedence over punishment. SB 590 and HB 2084 both essentially impose a life sentence. PTA's position on these issues is based on the **Position** Statement Child Safety and Protection. Missouri PTA testified at the committee hearing in the house in support of HB 1995. Missouri PTA issued a JC/DC action alert in opposition to SB 590 and a JC/DC action alert in support of HB 1995. SB 590 passed the Senate. End of Session: SB 590 passed both houses. While it contained amendments from it's original form, MoPTA has concern over the language and has issued an alert asking Govenor Nixon to veto SB 590.

HB 1562, Haahr (R-134), would expand the definition with regard to child trafficking by adding the word 'advertising the availability of'. PTA addresses the issue of child trafficking through the <u>Resolution Child</u> <u>Trafficking</u> and supports such measures to deter recruitment. Missouri PTA issued a JC/DC action alert to support this bill. HB 1562 passed the House and Senate. This bill is now moving through the conference process. End of Session: Passed both the House and Senate and is currently waiting Governor Nixon's signature

SB 748, Nasheed (D-5), HB 1583, Allen (R-100), HB 1384, English (I-068), and SB 728, Sifton (D-1), would strengthen the current bullying law by expanding language to include actions that interfere with a student's educational performance, opportunities or benefits. Additionally it requires the law be applied to all students without exception. Cyberbullying is also defined and included in this act. PTA supports this action through both the MOPTA Resolution Bullying and the NPTA Resolution Against Bullying. MOPTA issued a JC/DC Action Alert for HB 1583. HB 1583 passed the House. End of Session: 1583 passed both House and Senate is currently waiting Governor Nixon's signature.

SB 646, Schupp (D24), HB 1546, Lauer (R-032), and HB 1656, Dunn (D-023), requires school districts to develop a suicide awareness plan and directs the department of elementary and secondary education to develop guidelines for schools to adopt a youth suicide policy. PTA supports plans that work to provide special preventative services in school through the <u>Child</u> <u>Safety and Protection</u>, and the <u>Resolution Youth</u> <u>Suicide Prevention</u>. Missouri PTA testified at a senate committee hearing in support of SB 646. A JC/DC Action Alert was sent to support both HB 1546 and SB 646. HB 1546 passed the House and SB 646 passed the Senate. End of Session: Passed by House and Senate awaiting Governor Nixon's approval.

Data Privacy

What happens to our personal data has become a hot topic.

We read about mass security compromises with our personal information with many conflicting reports about how to best protect your identity from those who seek to use if for illegal purposes. Our data is shared among companies and can be purchased.

How many of us stop to think about how data is used when it comes to our school districts, state or federal governments concerning our children? What data does our school system keep and what does it send to state and federal government?

As a parent you have the right to review and approve what data and with whom your child's information is shared. School districts must directly notify parents before their children participate in activities involving the collection, disclosure or use of personal information collected from students for marketing purposes, or to sell or otherwise provide that information to others for marketing purposes.

Parents must be given the opportunity to opt-out of these activities. Missouri PTA's website has great information to educate you and your local Unit about data privacy, for more information visit <u>http://mopta.org/student-data-privacy/</u>.

My day job entails managing programming for a poverty-addressing project in Springfield, MO. I work to engage our community to be part of the momentum built as a result of the rehabilitation and opening of a community hub (a former elementary school, left empty for years). It's an inspirational story (you can conduct an internet search and find newscasts, articles, and videos about The Fairbanks/Amy Blansit/Drew Lewis Foundation/Northwest Project) but the big picture has never been my inspiration. My inspiration lies in the hugs I receive from children each week when neighbors arrive for programming. My inspiration is the conversations I have with those that have less, yet give more. I'm inspired by the mom that makes me laugh by simply seeing joy in each program while her child's unnamed disability takes over his body more each week. I watch families as they leave and go home after programming and I miss them immediately.

I watch my own children serve, create friendships, and ask questions that I have no answer for. I don't know why some families struggle with generational poverty. Sure, I know the research and I've read the books, but I still don't know why. I don't know why my childhood was so different but I know my place now and it's to live where I'm inspired. Saturday, 6/25/16, we moved our family of 8 to one of the most impoverished and crime-saturated neighborhoods in Springfield and I've never felt more welcomed and inspired. I've had neighbors over for meals, 20 people volunteered to help us move, and gifts have been left at my doorstep each day since moving. I've never felt so immediately absorbed into the fabric of neighborhood.

I'm inspired by people who trump adversity with tenacity and live to tell me their stories. What's your inspiration?
