The ladies at that first meeting didn't even have the right to vote, but they knew that schools and children needed someone to look out for them and have their backs, so they committed and advocated for the children. Now it is our turn and on our watch.

Why do I  $\heartsuit$  PTA? I urge you each to look at the Purposes of the PTA. Ask yourself if you can honor those and if there is something you can do to help fulfill them. But don't despair even if you can't. I know someone else from the PTA will have your back and the backs of our children. Just like they have been doing since February 17, 1897, the PTA has been showing up to your community to secure adequate laws for the care and protection of children and youth. Someone has been spending time trying to get the word out on how to raise the standards of home life, and over 4 million members strive and advocate every day to promote the welfare of children and youth in home, school, and community. Now I hope you also  $\heartsuit$  PTA. Isn't it the right choice to make?

# PTA Founder's Day

During the month of February PTAs nationwide celebrate Founders Day. I'll admit when I

first became acquainted with PTA any notion of a long rich history rooted in advocacy for all children never hit my radar. In fact, growing up enrolled in all parochial schools where the concept of a parent organization was absent from the education canvas, my opinion of PTA could be summed up by the concept that 'PTA was a clique of those moms'. Even when my oldest started Kindergarten, and I encountered my first real contact with PTA, the focus in my local unit revolved primarily on programs, events, and fundraisers being held by only that PTA benefiting only those children and families who attended that school. It wouldn't be until my youngest entered Kindergarten five years later, as a newly elected PTA unit officer, when completely on my own I stumbled upon PTA's astounding history.

There are many reasons we preserve the events of our past, our history. Academia will point out the danger of history repeating itself if we are not knowledgeable of our past. Often we turn to history to reflect on the sacrifices of others whose work and efforts shaped the world in which we live. And, of course history can be the impetus of annual celebrations focusing on past accomplishments. By celebrating PTA's history, we pull a little bit from each of those reasons.

Never should we forget our children were once not afforded the rights and protections they have today. PTA's founders, Alice McLellan Birney and Phoebe Apperson Hearst (a Missourian), fought to bring about legislation on Child Labor because they felt it would be best, not just for the children but also our country, that children attend school rather than work in factories. This was PTA's first order of business after the official formation. These history blazing women spearheaded their nationwide cause at a time in our history when women did not have the right to vote and social activism was not viewed in a positive light. But it wasn't just mothers who joined Alice and Phoebe at that first gathering in February of 1897. They were joined by fathers, teachers, laborers and legislators. Since that first meeting PTA has worked to support the creation of Kindergarten classes, public health services, hot and healthy school lunches, a juvenile justice system, immunizations, arts in education, and school safety.

PTA does great things at the local level and those efforts should also be recognized and celebrated. However, it is important to remember the why of PTA. Why individuals were so passionate to work tirelessly, giving of their time and voice to raise the standard of life for all children. It is a testament of not only what was accomplished but what can be accomplished through our collective efforts. I know their work made a difference in my life growing up even if I didn't know it at the time and my parents were never part of any parent organization. I also know while the work hasn't just begun, so much has been accomplished, it is neither far from over.



# I O PTA Founder's Day

For as long as I can remember, the Hazelwood PTA Council has made their PTA Founder's Day Celebration the centerpiece of their year. On the first Thursday of February, the Council hosts a catered buffet dinner for over 800 PTA leaders, teachers, staff, students and community members. This event has three missions; honor the founding of PTA, celebrate the District's Teachers of the Year, and accept Scholarship donations.

These are some of the details that the Council incorporates into the night:

- The high schools take turns providing the musical entertainment.
- Each school/PTA may have a table with up to 24 seats. The district has three high schools, six middle schools, and 20 elementary schools. All have active PTA/PTSA's. In addition there is a gifted education building and three Early Childhood Education Centers.
- There is a table decorating contest using the PTA Reflections Theme. The school board serves as judges and a coveted traveling trophy is awarded.
- A local Boy Scout or Girl Scout troop is invited to present the Colors.
- PTA membership determines the seating order. PTAs with higher membership percentage based on enrollment get the prime tables right up front. Those with lower PTA membership totals are on the outer fringes.
- The school district provides plaques for all the Teachers of the Year and each of the Support Staff of the Year winners.
- The PTA holds a commemorative ceremony to honor the Founders of PTA.
- The PTA Council collects donations to its Scholarship Program. This year they expect to collect \$15,000 in donations from its PTAs, school departments and school leaders.
- Finally, the artwork is voted on for the Council's Annual Run/Walk t-shirt.

All of this is accomplished by a small group of dedicated Hazelwood PTA Council leaders, the strong partnership they have with the district administration, and they cram it into just two hours. #### Missouri PTA joined the coalition to support the Streamlined Sales Tax Collections

This coalition is formed by the Missouri Budget Project (MBP), a group MO PTA works with regularly on funding issues. The MBP's mission is to improve the quality of life for all Missourians by informing public policy decisions through objective research and analysis of state budget, tax and economic issues. According to the MBP, Missouri tax laws have failed to keep pace with a changing economy, reducing the state's ability to invest in the well-being of its citizens. In particular, Missouri and other states that rely on sales and use taxes to fund public services have been losing revenue as a result of a failure to capture taxes that are owed for online retail purchases through remote sellers. A University of Missouri study estimated that Missouri missed out on \$358.3 million in state and local sales tax revenue in 2014. In addition to eroding Missouri's ability to invest in critical public services like education, health care and safe roads. The failure to compel remote online retailers to capture sales and use tax also creates a competitive disadvantage for Missouri's bricks-andmortar retailers who are required to capture sales tax.



#### Regional Meeting Survey Results Published

Attendees of the 2016 Regional Meetings on Education, and those unable to attend, were asked to complete one of two surveys that requested their views about the current path of education in the state of Missouri. That information has since been compiled and reviewed by DESE staff, allowing for more thorough discussion regarding the future of public education throughout the state.

<u>Follow-up information</u> from those who attended one of the Regional Meetings in person and thoughts from those who answered questions via an online <u>virtual meeting</u> are available.

### Learn the Signs. Act Early.

The <u>Centers for Disease Control and Prevention</u> sponsors a website designed for parents to access a wide variety of free, research-based resources on child development. Their newest resource, titled "<u>Milestones in Action</u>," is a free image library that features photos and videos of children demonstrating developmental milestones from two months to five years of age.

This tool was created to help both parents and early care providers identify developmental milestones in children and know if there is cause for concern.

Opportunity

Do you know a high school senior who is considering a career in teaching? Missouri PTA offers Teacher Education Scholarships for graduating High School Seniors. Each scholarship provides a stipend of \$500 per year up to a maximum of \$2,000.

To be eligible for this award, applicants must:

- Be a graduate of or graduating from an accredited Missouri public high school in a school district with at least one PTA/PTSA unit in good standing.
- 2. Have a higher than average scholastic standing.
- 3. Have outstanding potential aptitude for teaching, good character, and personality.
- 4. Show financial need.
- 5. Enroll in a college or university in Missouri to obtain a Bachelors/Masters Degree or a community college in Missouri to obtain an Associates of the Arts in Teaching Degree to begin their preparation for teaching.
- For each two (2) years of assistance, recipient must teach for one year in a Missouri public elementary or secondary school (or work in some other capacity as a certified educator).

Scholarship applications are available on the Missouri PTA website but must be submitted through the school counselor (only one application is accepted per school). Deadline to apply is determined by each school prior to Feb. 15. For more information visit the Missouri PTA Website.
