Leadership Development is vital to the success of PTA units as the future of tomorrow's PTA units requires the training of their leaders today. Missouri PTA is committed to the development, training and strengthening of leadership skills in it's local PTA Unit and Council officers, students, PTA Committee Chairpersons, teachers, school, personnel, states board members and general membership statewide. The Missouri PTA Advanced Leaders Project was developed to certify and recognize the advanced leadership accomplishments of Missouri PTA Leaders. By participating, Missouri PTA provides you with additional opportunities, exposure and hands on experience.

The Missouri PTA Advanced Leaders Project is a two-year project. To be eligible, the applicant **MUST** have completed the Missouri PTA Leaders Project. There are ten (10) different leadership training activities, programs and opportunities available. The project is complete when the participant finishes five (5) training requirements within two calendar years.

Upon completion of each leadership training event, a Missouri PTA Board Member will sign and date the participant's tracking card. It is the responsibility of the participant to keep track of the signed tracking card. Applications must be received by the August 31st deadline and each recipient will be notified that their application has been approved. Recipients become Certified PTA Advanced Leaders and are presented with an Advanced Leaders Project Pin and certificate at the annual Missouri PTA State Convention and will be recognized in *CONTACT* and on our website.
